## **III. POLICY PROGRAM UPDATES**

- A. Creative Sonoma
  - The deadline for artists to submit qualifications for the Fire Memorial Public Art Project was August 9. The project Task Force is now reviewing the 83 submissions received. They will narrow down the list to 5 finalists who will be invited to interview with the Task Force. An artist should be selected by the end of September.
  - Staff presented a draft Public Art Plan to the Board of Supervisors on July 16. Input was received on the draft plan as well as general direction on funding and governance for a County Public Art Program. The board requested a workshop on the topic and more detail on specific areas. Staff will return to the Board (date TBD) to move the discussion forward.
  - A leadership team of arts education experts has been invited to revise the current Arts Education
  - Framework 2019-2024. The local team will meet and work with statewide expert, Peggy Burt for two workdays to rethink and retool the Framework to better address equitable access to quality arts education. The work begins in October.

Board members discussed current and potential art projects taking place in their districts.

B. Business Services & research

Jack Kampmann gave a presentation of the EDC websites updates and the real time data now available for all cities.
