III. POLICY PROGRAM UPDATES

- A. Executive Director Update

B. Creative Sonoma

Arts Education Framework Revision

The team met in mid-November for a final day of work to revise the current countywide arts education plan with needed updates and strategies. Meeting slide deck. The team is comprised of several SCOE coordinators, CTEF, Windsor USD, Luther Burbank Center for the Arts, Creative Bridges, and Creative Sonoma. Creative Sonoma will meet with the team's facilitator in December and January to move the ideas into a draft. The plan is due to be completed by February.

Workforce Campaign

The #TEACHtheARTS campaign has been launched through Creative Sonoma and partner communication channels. Here is a press release. High school, community college, and university students are invited to learn more about careers in the arts and arts education on February 1, 2025, at College and Career Pathways in the Arts Day at SSU. Creative Sonoma will share our strategies and materials at a statewide meeting of arts education leaders on Dec. 6.

C. Broadband

Digital Needs Assessment:

In September 2024, EDC retained Los Cien to conduct a Digital Needs Assessment throughout Sonoma County to determine what barriers communities are facing to fully access and participate in the digital world. The Digital Needs Assessment focused on communities who scored low on the Human Development Index (HDI), which is a measure for a community's health, wealth, and wellbeing, as described in the Portrait of Sonoma and Health Action Together reports, along with other low-income areas. To ensure adequate representation of the populations most in need of these services, Los Cien partnered with several community organizations and attended in-person events to distribute the surveys.

In total, 579 responses were received. Fifty-seven percent (57%) of the respondents identified as Hispanic or Latino and 30% white. The average reported household income was \$36,000 and average size of household was 3.2 people. Interestingly, 80% of respondents reported having access to internet in their homes, either through home computers or cell phones. However, when

asked about internet speeds, costs, and devices used, there is a clear divide in the respondents' ability to fully access the internet. The full Digital Needs Assessment report is attached. Data highlights include:

- 80% of Low-Income HH are paying more than \$30/month on internet, despite being eligible for low- income internet plans.
- 60% are receiving service speeds below State/Federal standards (100/20 MBPS) and yet majority (66%) are paying at least \$50/month.
- 44% reported having no devices or only a smartphone. That figure increases to 53% when isolating for households with school-aged children.

D. SMEDD

On Friday 11/15/2024, the SMEDD Board of Directors approved the next three-year partnership and planning grant for submission to the EDA. Leveraging this funding, the SMEDD conducts its baseline work of facilitating an annual Comprehensive Economic Development Strategy (CEDS) update, and monitoring progress on regional projects that are aligned with the CEDS. Below is a complete three-year workplan for the proposed application.

Their mission is to achieve collective impact to foster equity, belonging, and justice by working with their partners to provide high-quality immigration legal services and facilitating connections to culturally responsive social services.

2025-2030 plan will use a shared leadership model and build on the accomplishments of the previous strategic arts plan.

Workforce Campaign - Recent focus has been on distribution of printed materials for the #TEACHtheARTS campaign in the community and to high school, community college, and university arts departments. Social media advertising has led to much more engagement with the marketing pieces. Creative Sonoma is responding to inquiries from interested individuals as a result of the campaign.

College & Career Pathways in the Arts – a next step in the campaign Creative Sonoma continues to coordinate and promote a first ever College and Career Pathways in the Arts event at SSU in partnership with SSU and SRJC. High school, community college, and university students are invited to learn more about careers in the arts and arts education on Feb. 1. In addition to planning and coordinating, Creative Sonoma will present about the Creative Economy and Prop 28.

C. Broadband

CPUC has proposed to award \$17,010,997 to WiConduit and GigabitNow for two broadband expansion projects in West County.

Sonoma County, as a subgrantee, partnered with the California Emerging Technology Fund (CETF) on a \$12 Million statewide grant to fund training of digital navigators, conducting digital skills training courses, and outreach regarding affordable internet service offers.
